- Residential Board & Care Occupancy
- Healthcare (Limited Care)
- 5 or fewer resident facilities (R-3)
- Small facilities (6-16 residents) (R-4)
- Large facilities (17+ residents) (I-1)
- Enhanced Care
- Memory Care

### LET'S COMPARE





- Prior to 8/1/2021: Housing with Services (HWS) MN Statute 144D
- 8/1/2021: Assisted Living Licensure MN Statute 144G

#### Conversion

(Converted from HWS to new AL License):

- ALF or ALFDC
- Already have an HFID
- Time period to convert is passed
- Considered existing, non-conforming

### **Provisional**

(New license after 8/1/21):

- Provisional ALF or provisional ALFDC
- Issued a new HFID after completing an application
- Every new ALF or ALFDC moving forward

### **ALF** – Assisted Living Facility

- A facility that provides sleeping accommodations and assisted living services to one or more adults.
- 3 categories
  - 5 or fewer residents
  - 6-16 residents
  - 17+ residents

# **ALFDC** – Assisted Living Facility with Dementia Care

- A licensed assisted living facility that is advertised, marketed, or otherwise promoted as providing specialized care for individuals with Alzheimer's disease or other dementias. A secured dementia care unit must be licensed as an ALFDC.
- Can be any # of residents

R-4 occupancy 144G.45, Subd.1-5 Life Safety Code (Chapter 32 – small facilities) FGI design requirements

#### 17+ residents

I-1 occupancy
144G, Subd.1-5
Life Safety Code (Chapter 32 – large facilities)
FGI design requirements





### Assisted Living | 10+ Year LOOK AHEAD



Projected 100,000+ additional 80+ yrs old (from the MN State Demographer)

#### **CURRENT FACILITY SIZE BREAKDOWN**

- ~53% 5 residents or less facilities
- ~19% 6 16 residents (small)
- ~28% 17+ residents (large)
- 64% Metro
- 36% Out-State
- ~26% Dementia Care Facilities
  - ~67% of all residents are in ALFDC's\*

### PROJECTED NEED (50% of 100,000+ 80+ yr olds)

- 26,500 residents (5,300 [5 or less] facilities)
- 9,500 residents (594 small facilities)
- 14,000 residents (140 large facilities)
- 32,000 residents (Metro)
  - 3,392 = 5 or less facilities
  - 380 = small facilities
  - 90 = large facilities
- 18,000 residents (Out-State)
  - 1,908 = 5 or less facilities
  - 214 = small facilities
  - 50 = large facilities

~3,200 total facilities As of today,

only 2,347 facilities

Total facilities still needed:

~6,000

ALFDC's needed:

~750 (all sizes)




### License Data – Nursing Homes

# Can someone license a NEW nursing home in MN?



### **NURSING HOME MORATORIUM**

MN Statute 144A.071, Subd. 2

#### Moratorium.

- (a) The commissioner of health, in coordination with the commissioner of human services, shall deny each request for new licensed or certified nursing home or certified boarding care beds
- No new nursing home licenses
- No more licensed beds



### **MORATORIUM EXCEPTION PROCESS**

- Nursing homes can still renovate, expand SF, or "move"
- Bed increases are not allowed unless purchased from another NH
- Thresholds for project sizes:
  - Under \$1,000,000- reimbursement not affected
  - Between \$1,000,000 and \$2,421,908
    not required to apply for exception
  - Over \$2,421,908 approval required

### THE STATE OF NURSING HOMES

- Nursing homes aren't very profitable
- REITS or Companies that own many NH can turn a profit.
  - Still not much money for updates, renovations, etc.
- Hard to operate and provide good care for 1 or 2 off facilities
- Construction is expensive, partly because of regulation (MEP, EE)



### THE STATE OF NURSING HOMES

- Institutional
- Depressing
- 1-3 year life expectancy
- CMS reimbursements aren't much
- Demanding work for staff
- No system in place to allow nursing homes to thrive.
- How do we change? Do we care?



### WHAT'S THE SOLUTION?

- Assisted living with dementia care licenses
  - No cap on licenses
  - Still a huge need for 10+ years
  - ALFDC's are required to be built like nursing homes.... sort-of



### **State** – Nursing Home License

- MN Statute 144A
- MN Rules 4658
  - Physical environment requirements

### **Federal** – Skilled Care Facility Certification

- Required if receiving Medicare/Medicaid
- SOM (State Operations Manual)
  - Issued by CMS
  - Governs certification of Skilled Care Facilities
  - Appendix P Long Term Care
  - Appendix PP LTC Interpretive Guidelines
  - Appendix I Life Safety Code Surveys
  - Appendix Z Emergency Preparedness

### **STATE - MN RULES 4658**

- Resident room size and design requirements
- Toilet room requirements
- Dining, dayroom, and activity floor area requirements
- Building elements:
  - Handrails, drinking fountains, etc.
- Commercial kitchens regs.
- MEP requirements





### **STATE - MN RULES 4658**

- Construction details
- Existing and new requirements
- Fire alarms
- Nurse call systems
- Rehab services
- Waivers are allowed for many parts of the Rules

### **FEDERAL - LIFE SAFETY CODE**



- 2012 NFPA 101 Life Safety Code.
  - New (18) and existing (19) chapters
- Additions, renovations, new construction, etc. are required to meet LSC because nursing homes are surveyed to that standard.
- LSC is not used the same as the MNSBC



### FEDERAL - HEALTHCARE FACILITIES CODE




- 2012 NFPA 99 Healthcare Facilities Code
  - Entire code applies
  - Risk-based requirements for electrical, gas, and other critical systems.
  - PCREE Chapter 10
  - Essential Electrical Systems

### **SITE REQUIREMENTS SUMMARY** 144G.45, SUBD. 1

- Utilities
- Emergency vehicle access
- Not going to flood
- All weather walk from exit/service doors
- Outdoor space for residents



### FIRE PROTECTION & PHYSICAL ENVIRONMENT 144G.45, SUBD. 2 - SUMMARY

- MN State Fire Code Compliance
- Smoke Alarms
- Fire Extinguishers
- Maintain Physical Environment
- Fire Safety and Evacuation Plans
- Distinct Hazards to Life



#### LOCAL LAWS APPLY 144G.45, SUBD. 3


- Must comply with all:
  - Ordinances
  - Regulations
  - Codes
  - Standards, etc.



#### **FGI REQUIREMENTS**

144G.45, SUBD. 4

- All assisted living facilities with six or more residents
- 2018 edition of the Facility Guidelines
   Institute "Guidelines for Design and
   Construction of Residential Health, Care and Support Facilities" all new licenses or new construction.




#### LIFE SAFETY CODE STATUTE SUMMARY

#### 144G.45, SUBD. 5



- 2018 NFPA 101 Life Safety Code.
- ALF's Chapter 32 Residential Board and Care Occupancies.
  - 32.2 Small facilities (6-16 residents)
  - 32.3 Large facilities (17+ residents)





#### MN STATUTE 144G.81 – ALFDC'S


- Additional ALFDC requirements include:
  - 144G.81, Subd. 1-3
    - 144G.81, Subd. 1 (HVA)
    - 144G.81, Subd. 2 doesn't exist
    - 144G.81, Subd. 3 (LSC)



#### LIFE SAFETY CODE STATUTE SUMMARY

144G.81, SUBD. 3





- ALFDC's Chapter 18 Healthcare (limited-care) Occupancies.
  - All size facilities

#### LEGISLATIVE CHANGES - 2025 144G.10, SUBD. 1 AMENDED

- Subd. 1C added language
- 1 license for each "building"
  - Meant to be 1 roof, 1 license
- All AL licenses need to be separated from other Als or other occupancies by a 2-hr fire barrier



# Assisted Living Submittal Process



#### SUBMITTAL SUMMARY 144G.45, SUBD. 6




- For ALFs AND ALFDCs
  - New licenses
  - New construction
    - Renovations, remodels, etc.
    - Not replace in kind or general maintenance
- Drawings need to be signed by an architect



#### **SUBMITTAL SUMMARY**

144G.45, SUBD. 6





- Similar drawings you will need to obtain a building permit.
- You have 1 year to start construction after approval of the drawings by MDH.
- Schedule your inspection at about the same time as substantial completion.
- Life safety plans need to be kept on file at the facility.

Should be done at same time as building permit application.

#### **NEW LICENSES**

- Intake Team or General Inbox
- License is broken into 2 tracks
  - 1. Engineering Services (plan review)
    - a. Physical Environment section only
  - 2. Credentialing (other licensing items)
    - a. All other sections: Authorized Agent, UDALSA, Owners, Insurance, etc.
- Paradise An antiquated program that tracks <u>every</u> HFID
- Perceptive Content Sim to MNDOLI, but not as good


- A new license application has been paid for or,
- A new construction project for existing license submittal form and drawings are received





# What agency in Minnesota is responsible for nursing home surveys?



#### **Survey Process**

#### Similar for both AL and NH

- Task 1 Offsite Survey Preparation
- Task 2 Entrance Conference/Onsite Prep.
- Task 3 Orientation Tour
- Task 4 Information Gathering
  - Building & Policy/Paper Review
- Task 5 Information Analysis and Decision Making
- Task 6 Exit Conference

#### **MDH AL Survey Evaluators**

At least 3 MDH employees are going to be in your building during a survey.

- Nurse evaluator (everything except kitchen & building)
  - **Emergency Preparedness**
- Food Code evaluator (kitchen used by staff only)
- Physical environment evaluator

#### **Types of Assisted Living Surveys**

- Conversion
  - For all facilities that converted from HWS to AL, no matter # of residents
- Provisional
  - The 1<sup>st</sup> survey all facilities get
  - Determines if the facility will receive its full license
  - Could be a Life Safety Code survey
- Life Safety Code
  - Type of LSC survey depends on size or license type
    - 6-16 residents (Chapter 32 Small board and care occupancies)
    - 17 or more residents (Chapter 32 Large board and care occupancies)
    - Dementia Care (Chapter 18 Healthcare (limited-care)

- Life Safety Code Survey
  - 2012 NFPA 101
    - Plus other NFPA associated codes: 10, 25, 72, 80, 99, 110
  - New & Existing chapters surveyed
- MN State Deputy Fire Marshal
  - Regional
- Occur about once per year
  - Often around the same time of the year
- 2786R K Tags
- Emergency Preparedness

- Converted from HWS to new AL licensee

Are patient care-related electrical appliances and equipment required to be tested?

- No why?
- No code path from 2018 LSC to Chapter 10 of NFPA 99
- How about for nursing homes?
- Yes why?
- NFPA 99 adopted in full by CMS

## ?

#### **REGULATORY SCENARIO 2 – OUTLET TESTING**

#### Facility Info:

- 32 resident ALFDC
- Received license on 03/15/2023

Is outlet/receptacle testing required?

- NO why?
- No code path from 2018 LSC to Section 6.3 of NFPA 99
- NFPA 99 was not adopted in its entirety like Nursing Homes, only EE Systems
- Nursing homes?
- Yes and keep doing it

#### **REGULATORY SCENARIO - SHOWERS**

#### Facility Info:

- 10 resident ALF
- Received license on 06/18/2024

Do residents need access to a shower without going into a corridor?

- No why?
- FGI Formal Interpretation <a href="https://fgiguidelines.org/wp-content/uploads/2022/06/FGI-interps Guidelines 2018 RES 180430.pdf">https://fgiguidelines.org/wp-content/uploads/2022/06/FGI-interps Guidelines 2018 RES 180430.pdf</a>
- Covers small (less than 5) and medium (6-15 residents), ALF or ALFDC
- Watch resident #16!
